Comprehensive Needs Assessment

Needs Assessment Overview

Reading and Writing are content areas of greatest need of improvement. Blum ISD needs to be more intentional in the use of consistent curriculum that closely follows the standards and the academic vocabulary should be consistent and build in complexity with time. Writing instruction must occur in all grade levels regardless of when the writing is assessed by STAAR.

Blum ISD has a large at-risk population, and decisions made by the district must consider this information carefully.

Communication processes need further development to foster stronger connections and mutual respect among the faculty and staff.

Due to COVID-19, the district faces uncertainty.
